## Panelist Bios

**Danny Yoder** (MCRP 2015) is a Senior Project Manager in the Transit Development group at the New York City Department of Transportation. His primary focus is on developing and advancing transit policies that improve the usefulness of NYC's transit system for city residents. Prior to his current role, Danny worked in NYCDOT's Special Projects group managing policy and planning studies. Danny earned a Master of City and Regional Planning degree from the Bloustein School in 2015.

**Patrick Brennan** (MCRP 2010) is a Senior Fiscal analyst for the Office of Legislative Services, a nonpartisan arm of the State Legislature which provides research, bill drafting, and technical expertise to all members of the State Legislature. In the Authorities Section, he is responsible for staffing the Senate Economic Growth Committee and reviewing and analyzing the budgets for the Department of Transportation, New Jersey Transit, and the Motor Vehicle Commission. Mr. Brennan has broad bill drafting responsibilities in the areas of transportation, utilities, and economic development. Recently, he has been heavily involved in the recent investigations into NJ Transit, The Transportation Trust Fund renewal, the gas tax increase, the Statehouse renovation, and the Grow and ERG tax incentive programs.
